- Mayor Neville and the Board members requested additional information on the training options for Angela and Ashlyn. Administrator Niswender replied that she would get the information and send it to the Board members.
- Trustee Walpole made a motion to approve travel for Nancy Niswender to attend the NYCOM Winter Legislative Meeting February 1-3, 2026 at the Albany Marriott which will be funded by the NYSSMFO, seconded by Trustee Holl, all in favor, carried.
- Mayor to appoint Kathleen McCracken - to 5 year term - Planning Board ending April 2030
- Mayor to appoint Rena Calwell as crossing guard at a rate of \$15.50
- Trustee Conger made a motion to approve the 2026 Town/Fire Contract for \$167,000 & 2026 Town/Ambulance Contract for \$188,000, seconded by Trustee Walpole, all in favor, carried.
